## Florida House of Representatives – House Redistricting Committee Redistricting Update – March 19, 2012

### Update on the Extraordinary Apportionment Session

The Florida Senate released its first look at proposed revisions to the state senate map on Saturday. As the Extraordinary Apportionment Session moves forward this week, the Senate will post subsequent proposed amendments to the state senate map at <http://www.flsenate.gov/Session/Redistricting/Plans>. Two new amendments, 9018 and 9020 were filed today, so make sure to check back from time to time. The Extraordinary Apportionment Session pertaining to the state senate map must conclude by 11:59 p.m. on Wednesday, March 28, 2012.
