2. Osceola County be combined with Orange County into one Congressional District because our communities share common interests here in the metropolitan Orlando area.

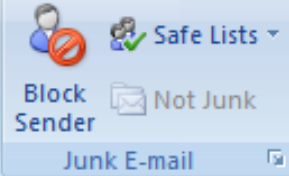
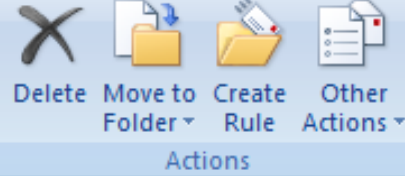
